1. Meeting called to order by Township Supervisor, Richard Raffaelli at 5:32 pm
2. Pledge of Allegiance recited
3. Roll call; Cathy Anderson – present, Becky Griffin – present, Scott Meyers – present, Scott Beishuizen – present, Richard Raffaelli – present. 2 Members of the Public present.
4. Public Comment: None
5. Agenda: Scott Meyers made a motion to approve the agenda, support for the motion offered by Scott Beishuizen, voice vote, 5 ayes, 0 nays, discussion followed, motion carried.
6. Approve Minutes: Scott Beishuizen made a motion to approve minutes from 09/02/2025 Board Meeting and Minutes from 09/10/2025 Special Board Meeting, support offered by Scott Meyers, voice vote; 5 ayes, 0 nays, discussion followed, motion carried.
7. Fire Board Report: The Fire Dept responded to 55 calls in the month of August, 35 of these calls were of a medical nature. 7 sets of turnout gear scheduled to arrive by end of November 2025. The thermal imaging camera on Truck 243 is broken and needing to be repaired in the amount of \$3,000 or to be replaced in the amount of \$5,500. The valve of truck 261 is leaking and needs to be repaired in the amount of \$21,000. 5 lengths of one and three quarters inch hose need to be replaced; the cost is about \$23,000. Chief is looking into ordering a training mannequin for fire and rescue training, the cost of this is about \$1,600.
8. Planning Commission:
Zoning Administrator: Four zoning permits have been issued since September 2, 2025, with a total of \$400 collected. Letters regarding blight/junk were sent September 16, 2025, a total of six letters went out, five of these were follow up letters from the previous Zoning Administrator. The Township has received feedback from 4 of the property owners, who have either responded to the Township or who have begun/resumed cleanup.
9. Old Business:
 - a) Update: \$1 million slated for enclosed facility, \$400k slated for the MDOT Tunnel on M-20, \$1 million slated for the Pool Project and \$1 million in supplemental money has been requested for the road budget.

10. New Business:

- a) Approval of the 2026 Budget for Shelby – Benona Fire District, Resolution # 251009-1. Motion made by Scott Meyers to approve the annual 2026 fiscal year budget for the Shelby – Benona Fire District in the amount of \$618,580.00 fiscal year beginning January 01, 2026, and ending December 31, 2026. Support for the motion offered by Scott Beishuizen, discussion followed, roll call vote; Scott Meyers – yes, Scott Beishuizen – yes, Cathy Anderson – yes, Becky Griffin – yes, Richard Raffaelli – yes, motion carried.
- b) 425 Agreement between Grant Township and Shelby Township; Scott Meyers made a motion to move forward with a 425 agreement and special assessment for Lewis Farms' property on the south side of M-20/Stony Lake Rd., approximately 10 acres that is currently used as overflow parking, Scott Beishuizen offered support for the motion. Roll call vote; Scott Meyers – yes, Scott Beishuizen – yes, Becky Griffin – yes, Cathy Anderson – yes, Richard Raffaelli – yes, discussion followed, motion carried.
- c) MOU with OAM for TACC: Cathy Anderson made a motion to approve the MOU between Shelby Township and Orthopedic Associates of Muskegon, support for the motion offered by Becky Griffin. Roll call vote; Cathy Anderson – yes, Becky Griffin – yes, Scott Meyers – yes, Scott Beishuizen – yes, Richard Raffaelli – yes, discussion followed, motion carried.
- d) Zoning Fee Review: Currently agriculture does not pay the \$100 zoning permit application fee. Motion made by Cathy Anderson to charge the same \$100 zoning permit fee to agricultural practices as is charged to all other zoning permit applicants, support offered by Becky Griffin. Roll call vote; Cathy Anderson – yes, Becky Griffin – yes, Scott Meyers – yes, Scott Beishuizen – yes, Richard Raffaelli – yes, discussion followed, motion carried.
- e) Trunk or Treat downtown Shelby, Friday, October 31st starts at 5:30 pm.
- f) Shelby & New Era Chamber of Commerce Christmas Event. Becky Griffin made a motion to approve the Township's participation in both the Christmas Event and the Trunk or Treat event, and to approve a budget of \$300 for both events, motion supported by Scott Beishuizen, roll call vote.
