

Shelby Township Board Minutes April 1, 2024 6:00pm

- 1. Meeting called to order by Richard Raffaelli at 6:00 pm
- 2. Pledge of Allegiance recited
- 3. Roll Call: Cindy Rapes present, Scott Meyers present, Richard Raffaelli present, Cathy Anderson present, Becky Griffin present. Absent 0. Others present-3 visitors.
- 4. Public Comments: John H questions about maintenance and upkeep at Shelby Township Community Park.
- 5. Motion made by Cathy Anderson to add line F to new business agenda for new carpet/vinyl flooring in Shelby Township Office, seconded by Scott Meyers, discussion followed, all in favor, motion carried
- 6. Motion to approve minutes from 3-4-2024 Board Meeting and to approve minutes from 3-20-2024 Special Meeting. Motion made by Scott Meyers, seconded by Becky Griffin, discussion followed, all in favor, motion carried.
- 7. Fire Board Report: 25 calls in February. Fire Chief has been trying to work with the Mexican Grocery owner regarding permits and fire inspections. Fire Department checking into the possibility of direct deposit to pay Firefighters, due to problems with Firefighters not cashing checks. First fire drill held at new Shelby Elementary School, corrective measures taken. Polar plunge challenge raised \$400 for Grant Fire Department and another \$400 for Shelby-Benona Fire Department. Two new Firefighter put in applications.
